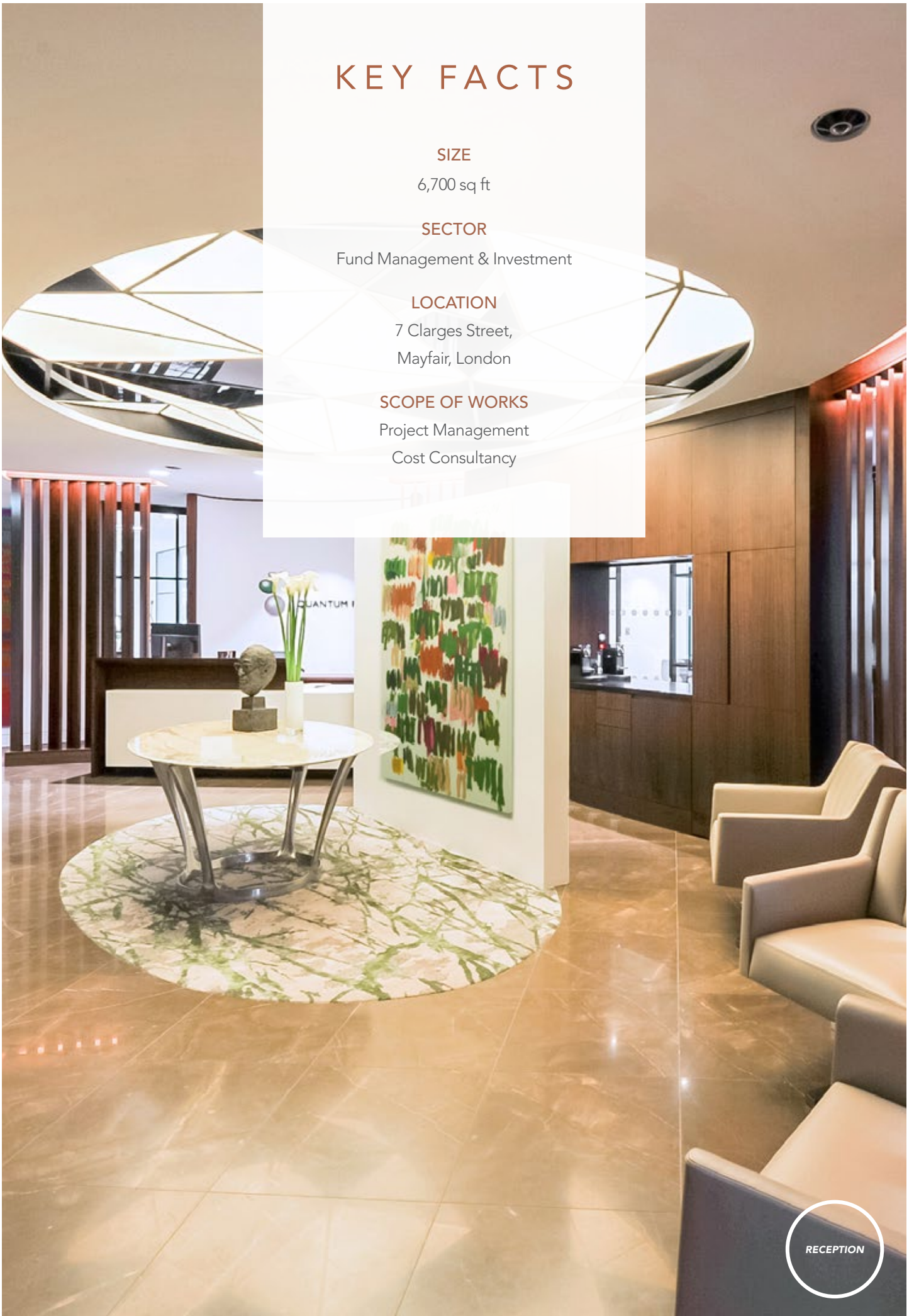

We are proud to announce the successful completion of the new London office for Quantum Pacific Capital at 7 Clarges Street.

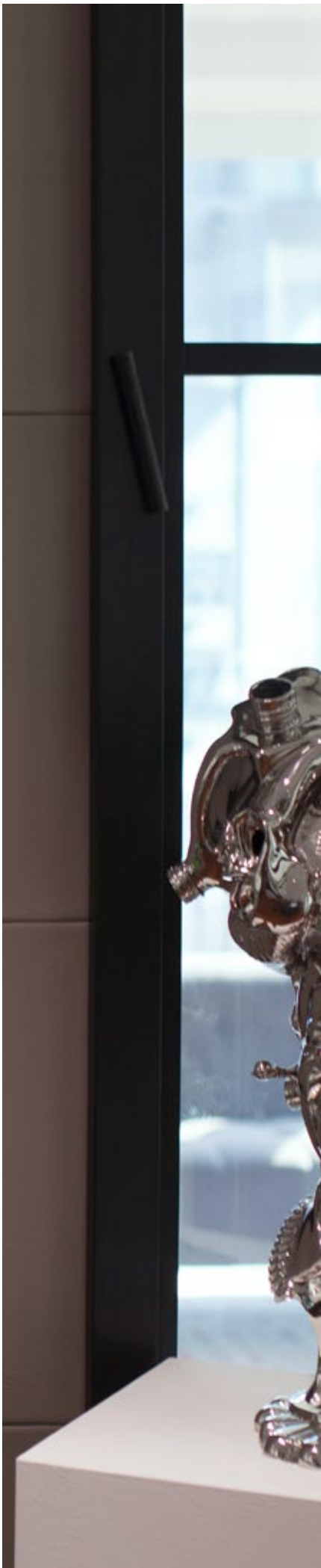

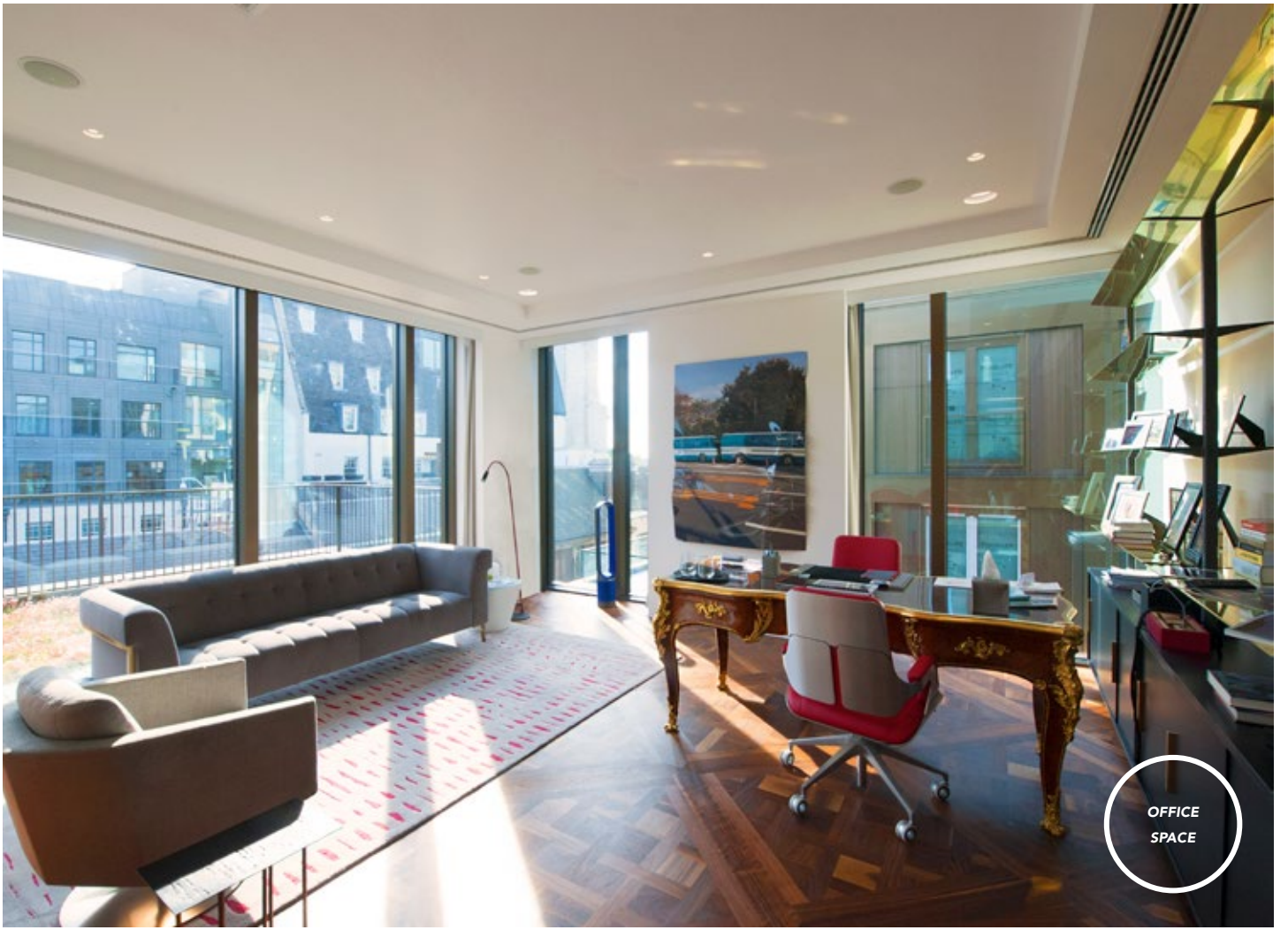
